- Staying in my own home is the cheapest option



Independent Retirement Living

- Usually 55+ restriction
- If medical or personal care is needed, the resident may contract those services on their own
- May offer housekeeping, meals, transportation to medical appointments and activities
- Designed for healthy, independent residents
- •\$3,000 \$6,000/month



- Independent Retirement Living
- Continuing Care Retirement Community (CCRC)

- Offers independent living through skilled nursing
- Resident can receive the array of care without relocating
- Typically have long-term contracts
- May have Buy-In fee
- •\$5,000-\$12,000/month

- Apartment-style housing
- Offers assistance with residents' activities of daily living (ADLs)
- 2 or 3 meals per day are offered in a congregate dining room
- Medication management
- \$4,000-\$8,000/month

- Often referred to as a "boarding house"
- Offers care services
- Offers congregate meals
- May have shared bathrooms
- \$4,500-\$8,000/month

- Private or shared bedrooms
- Private or shared baths
- Home cares for up to 5 residents
- Provides assistance with ADLs
- Provides meals in a family setting
- Highest ratio of caregivers to residents of all housing types
- \$4,500-\$10,000/month

- 24-hour nursing care
- Hospital-like setting
- Care provided by medical professionals
- Typical stays are for rehabilitation after accident, incident or surgery
- \$375 average per day if paying privately
- Medicare may cover up to 100 days\*

- This is not a guarantee of Medicare paying for a 100-day stay
- Patients must meet
   Medicare criteria and
   requires regular
   reviews

- 24-hour nursing care
- Hospital-like setting
- Care provided by medical professionals
- Typical stays are for rehabilitation after accident, incident or surgery
- \$8,000-\$16,000/month
- Medicare may cover up to 100 days\*

- Provide care for those dealing with
  Alzheimer's or another form of dementia
- Provide assistance with ADLs
- Private or shared bedrooms
- Private or shared baths
- May offer secured units for those that wander or are exit-seeking
- \$6,000-\$10,000/month

- Respite Care

- Provides care for a senior when the current care provider cannot
- May be offered by a retirement living, assisted living or adult care home
- Allows family caregivers a break to step away from the stresses of caregiving
- Most communities offering respite put a cap on the number of days that a senior can be cared for; 30-days

- Adult Day Center

- Provide care during normal work hours
- 3-types of centers:
  - Focusing on social interaction
  - Providing medical care
  - Targeting Alzheimer's care
- Allows the recipient to stay within their community while a caregiver goes to work
- Allows the recipient a break from their caregiver
- Provides social stimulation
- Provides structure to daily activities
- Average fee is \$20-25/hour
